Assessor Crowley reported that the first installment for tax bills is due June 28, 2019; with the second installment due September 27, 2019. The 2019 Quadrennial notice of changes for all taxpayers will be published August 1, 2019.

Highway Commissioner Dan Conness reported that the highway crew continues to work on tree trimming, tree stumping and culverts as the weather permits. He further reported that they have chosen an architect to prepare plans and review the drawings for the new building being constructed west of the existing building to better see the department grounds from their offices. They are also in receipt of contractor bids and would additionally like to consider new fencing around the property. Commissioner Conness reported on the district legislative funding from the State Capitol Bill as a funding source for replacement of the existing building

Administrative Assistant Paula Lind reported on the May General Assistance Census.

Supervisor St. Angel reported on project for a Rockford Township Building.


**Meeting Adjourned:**




