Supervisor St. Angel reported that due to new property ownership of the present General Assistance Office location, he discussed the tentative purchase of a new property to house the General Assistance Office.


Meeting Adjourned:

Next regular Town Board meeting will be held on Tuesday, July 2, 2019 at 4:30 p.m. at 119 N. Church Street, Room 400.


