**Reports:**

Assessor Crowley reported that all assessments will be published the third week in August and available on-line. He further reported that property values and a stronger sales market have increased values. The complaint process can be accessed on-line, and the deadline for filing is September 16, 2019.

Deputy Highway Commissioner Brad Trent reported on a cooperative EPA partnership grant, and that the crews were working on completing drainage projects within the township that included a retention pond. He also reported on the department's salt dome construction. He further reported that Commissioner Conness continues to meet with the architect on final plans for the new highway building. He intends for the bid process to go out in mid-September and project completion by March 2020. Commissioner Conness continues to work with the TOI Legislation Liaison and both Senator Stadelman and Representative West for approval of Capitol Development Funds for additional funding.

Administrative Assistant Paula Lind reported on the July General Assistance Program census.



Meeting of the Town Board adjourned at 5:07 PM.


