Highway Commissioner Dan Conness presented the Fiscal Year 2020/2021 Road & Bridge and Road & Bridge Retirement Fund budgets.


Meeting Adjourned

The next Town Board meeting will be held on January 21, 2020 at 4:30 pm at 119 N. Church Street, Room 400.


