Assessor Crowley reported 2020 assessments will be published August 5, 2020. Deadline for assessment complaints is September 4, 2020, and his office is prepared for tax assessment inquires.

Highway Commissioner Conness reported that the highway department has started the resurfacing projects, and stated the county-wide seal-coating project has been completed. He further reported that the road project for Blackhawk/Hwy 251/to the Cherry Valley line requires an IDOT grant approval. As well, the highway department intends to complete the grinding on Spring Brook Road this year. Commissioner Conness reported that they have completely moved into the new building and the temporary trailer has been removed. Lastly, they are spreading grass seed to complete their landscape project.

Supervisor St. Angel reported that the General Assistance Program currently has 105 open, active clients. Clients are permitted into the building by appointment only for the continued safety of the staff.

Trustee Vella moved to approve the bills as presented. Trustee Johnson seconded the motion. The motion was approved unanimously.




