Trustee Mark moved to approve the minutes of the March 2, 2021 meeting. Trustee Vella seconded the motion. The motion was approved unanimously.

Transfers:

Trustee Johnson moved to approve General Assistance Fund transfers from the underexpended line items Education and Training to line item Telephone for total sum of \$1,300.00 and from line item Insurance/Bonds to line item New Equipment for total sum of \$21,400.00. Trustee Mark seconded the motion. The motion was approved unanimously.

Trustee Johnson moved to approve Town Fund transfer from the underexpended line item Training/Travel to line item Financial Program for total sum of \$3,205 Trustee Vella seconded the motion. The motion was approved unanimously.

Trustee Manzullo moved to approve Assessor's Office transfer from the underexpended line item Insurance & Bonds to line item Office Supplies for total sum of \$11,000.00. Trustee Vella seconded the motion. The motion was approved unanimously.

Reports:

Assessor Ken Crowley reported that the Board of Review has completed all assessment complaints. He further reported that residential sales are at an all-time high, however, our region is experiencing low real estate inventory. Assessor Crowley believes commercial complaints will be on the rise this year. He reported no firm date on the tax bill mail date. 2020 assessments will be published in August. He lastly reported that he will be one of four panelist for the Illinois Property Assessment Institute to discuss COVID disaster effects on businesses.

Highway Commissioner Conness reported on yesterday's snow event. He further reported purchase of a used service truck, as the department continues to update their equipment fleet. He also reported pending work on salt dome, landscaping, and are looking at an additional storage building. Highway Commissioner Conness reported that they are pending union negotiations with Teamsters Local 325 for contract expiring April 30, 2021, and the need for a competitive wage package to keep good employees. He lastly responded to Trustee Johnson's question on staffing during COVID. The highway department is maintaining regular hours, following CDC guidelines, and have remained healthy.

Administrative Assistant Paula Lind reported on the February General Assistance Community Work and Job Training Program.

Trustee Johnson moved to approve the bills as presented. Trustee Vella seconded the motion. The motion was approved unanimously.
