Assessor Ken Crowley reported that the tax bills are projected to be mailed mid-May with a due date of mid-June. He hopes to have final dates to report at the May 4<sup>th</sup> meeting. Additionally, his office is working on 2021 assessments.

Highway Commissioner Conness reported that the highway crews are working on tree trimming and stumping. He further reported that the union contract has been ratified. The contract includes higher wages and benefits that will allow the highway department to offer a competitive package to maintain staffing. Highway Commissioner Conness reported on their continued efforts of updating their fleet of work vehicles by purchasing used equipment from the State of Illinois. They have increased their average vehicle age from 23 years to a 14 year average.

Administrative Assistant Paula Lind reported on the March General Assistance Community Work and Job Training Program Census.
