The Regularly Scheduled Meeting of the **Board of Trustees of the Town of Rockford**, held at 315 North Church Street, Rockford, Illinois was called to order at 4:30 PM.

Call to Order:

Supervisor St. Angel called the meeting to order.

Supervisor St. Angel led the meeting with the Pledge of Allegiance.

Approval of Minutes:

Trustee Wilson moved to approve the minutes of the May 20, 2025 meeting. Trustee Goral seconded the motion. The motion was passed unanimously.

Public Participation:

Supervisor St. Angel reported receipt of correspondence from the City of Rockford, for informational purposes only, regarding a Public Hearing held for the North Redevelopment Project Area to be known as the River District that was held on June 2, 2025 at 5:00 pm.
