## **Correspondence and Communication:**

Supervisor St. Angel reported receipt of the 2026 TOIRMA dividend in the amount of \$24,106.

Trustee Wilson reported "Eliminate Racism 815 Presents: Community Policing" will be held at the Nordlof Center on Wednesday, March 25, 2026.

## **Transfers:**

Supervisor St. Angel presented transfers for the General Assistance Fund as follows: From 15.11.651 Office Supplies to 15.11.595 Building Maintenance for a total sum of \$10,900.

Assessor Crowley presented transfers for the Assessor's Office as follows: From 01.12.901 Contingency to 01.12.422 Real Estate Clerks Salaries for a total sum of \$1,500; From 01.12.901 Contingency to 01.12.461 FICA for a total sum of \$1,500; From 01.12.901 Contingency to 01.12.552 Telephone for a total sum of \$7,500; From 01.12.463 IMRF to 01.12.591 Insurance & Bonds for a total sum of \$18,000; From 01.12.562 Education & Training to 01.12.538 Services & Consultants for a total sum of \$3,000.

Deputy Highway Commissioner Palm presented transfers for the Road and Bridge Fund as follows: From 06.11.525 Special Projects a total sum of \$121,000 transferred to 06.11.533 Legal Expense an amount of \$11,000, 06.41.512 Repair of Machinery an amount of \$100,000 and 06.41.518 Bridges/Culverts an amount of \$10,000.

Assessor Crowley reported the office is finishing up the 2025 assessment year. The Winnebago County Supervisor of Assessments is closing the year which will trigger the tax bill generation process. He further reported the office is working on tying up loose ends to roll over the year to 2026.

Deputy Highway Commissioner Barry Palm reported crews are removing road postings. Crews have been plowing and salting the last two days after a snow event.

Director of Accounting and HR Vicky Carlson reported on the General Assistance Community Work and Training Program for February 2026.
